- Work continues on the construction projects at Bennet Elementary and Palmyra High School. Updated student-created videos and construction progress pictures are now available to view on our district website at www.districtorl.net
- As part of our monthly staff and student presentations, Nebraska Department of Transportation (NDOT) officials provided an update on a "first draft" traffic safety plan proposal to reduce traffic crashes and mitigate other traffic concerns in the Palmyra area. NDOT provided an overview of the initial plan design complete with an RCUT traffic concept.
